

This system can be configured for use with a Central Monitoring Unit that will identify specific residents and or doorways triggered the alert and works up to 999 residents. DepartAlert[™] can also be configured for double doors.




Resident Transmitter

Mount Door Monitor to the Wall

A Peel off yellow backing from adhesives (3) on the back of the door monitor. The door bar should be mounted to clean, smooth surfaces




B Adhere the door bar vertically centered to the outside of either door frame with cords facing up or down (in direction of power source).



Warning: If mounting door monitor near metal frame, mount at least 8" away from metal frame.

4 Test the System


A Test the active range of the door monitor by approaching the door with a resident transmitter activated from all different directions, making sure that alarm goes off from desired distances.

2 Plug in the AC Adapter




Note: Alarm will illuminate and beep to indicate system is functioning.


5 (Optional) Mount Magnetic Contact Switch

WHEN USING THE MAGNETIC SWITCH. THE ALARM WILL ONLY SOUND WHEN DOOR IS OPENED AND IF A RESIDENT WEARING A WRISTBAND IS WITHIN THE MONITORED FIELD.

A Screw magnetic contact (see below) to underside of door frame with wording facing open door. Lead cord along outside of door frame.



B Screw magnet (see below) to door with arrow facing up.



- **C** Magnetic contact and magnet must align perfectly to function.
- **D** Plug in magnetic contact switch to male plug attached to door alarm.

3 Activate the Resident Transmitter(s)

- A Place the Caregiver Key on the face of the white transmitter in the lower right hand corner and hold button.
- **B** Transmitter will blink 3 times to indicate transmitter has been activated.




Warning: Transmitter bands are not to be placed on a wheelchair, walker or near iewelry. The correct placement is the the resident's wrist. This transmitter is battery operated and the life of the batterv is based on usage. (See TL-2012 instructions for further information.

6 *Test the System with Magnetic* **Contact Switch**

- **A** Test the door monitor with the magnetic contact switch installed by opening the door with an activated resident transmitter in hand. Door monitor will sound when door is opened.
- **B** To silence alarm, place the Caregiver Key over the blue sticker on the door monitor. Caregiver Key



C To retest, wait approx. 20 seconds for monitor to blink (single light) before system is ready.
